Non-Compliance of HQrs. Office transfer orders.

Reference:

Hqrs. letter No. AN/II/2153/relieving/Joining dated 15.03.2017.

I am directed to refer HQrs letter under reference and to intimate that HQrs transfers orders are not being timely complied with thereby affecting the entire chain of transfer.

- 2. Alibi cited for noncompliance inter alia are yearly closing/work load / medical issue of reliever or substitute/ non posting of substitute/ representation by the officer for cancellation of transfer or change of place of posting.
- 3. Attention is invited to the instructions in the transfer orders and various other instruction issued by HQrs. from time to time that the relief of the officers shall not be deferred on the ground that a representation has been submitted for the change of place/office of posting or on the ground that the reliever has not reported/ been posted.
- 4. Further, the officers posted in/out of Hard station/AO GE offices must be relieved immediately from their present place of posting to facilitate timely repatriation. In this regard attention is further invited once again to HQrs. important circular no. AN/II/2153/Gen dated 16.07.2013 wherein it has been explicitly mentioned that in case of necessity arising out of retirement/ posting/ leave etc. Controllers may *attach* an officer from nearby office/station to an AO GE office till posting of a permanent SAO/AO by the HQrs. office. Also PCsDA/CsDA/PIFAs/IFAs have the authority to attach officers locally to the sub-offices wherever necessary.

Non-compliance of HQrs. transfer orders has a bearing on entire HR management of the department and has been viewed very seriously by the Competent Authority. It is therefore requested to relieve the officers as mentioned in Annexure A by 01.05.2017 and to comply with the transfer orders issued till 31.03.2017 by 15.05.2017 under intimation to this office.
