IFA 14 Corps, vide letter No. IFA/14 Corps/IDAS Corrs dated 03.04.2018 has sought clarification in respect of applicability of para 3.9(a) of DFPDS-2016 for CFAs in SHQs in respect of MoD order dated 05.07.2017 regarding Delegation of Powers for Post Contract Management for Revenue Expenditure. IFA 14 Corps has also referred to reference (ii) above in this regard.

2. It is clarified that Para 3.9(a) of DFPDS -2016 was deleted as the powers to conclude AMCs were delegated to SHQs (Vice Chiefs / Principal Staff Officer (PSO)) and as a result this provision is unnecessary in case of MoD CFAs. Para 3 of MoD (Fin) order dated 05.07.2017 is applicable to contracts where earlier the CFA was MoD.

3. In view of the above it is further clarified that para 3.9(a) of DFPDS-2016 continues to be applicable to SHQs/HQ IDS/AFMS.
