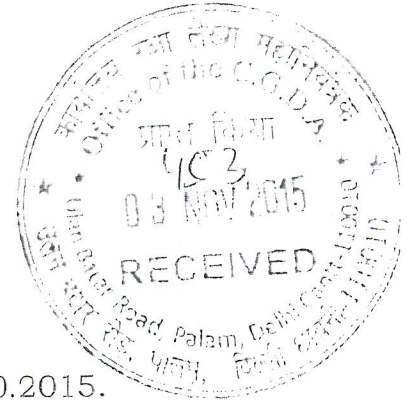

Sub - Review of DFPDS-2015

Ref - IHQ (Army) letter A/89591/Review/FP-1 dated 28.10.2015.

1. Copies of IHQ (Army) and IHQ (Navy) letters mentioned above are enclosed. Clarifications sought in letters are given below.
2. All sanctions / approvals accorded upto 26.10.15 under Inherent powers authorized vide DFPDS-2015, Addendum-1 and Special Dispensation letters shall be valid. After 26.10.2015, all cases under Inherent powers, pertaining to CFAs mentioned in DFPDS-2015, shall be processed as per Inherent powers available to them in DFPR-2006 in a particular sub-schedule or an item within that sub-schedule. As the structure of schedules have been rationalized/combined in DFPDS-2015, the Inherent powers will be applicable for the nature of item within a particular sub-schedule, as given in DFP-2006.
3. It is clarified that Inherent powers in Works, available to Navy CFAs in DWP-2007, are applicable after 26.10.15.
4. It is clarified that cases may be continued to sent to nominated IFAs, wherever they have been notified. The provision made in letter dated 26.10.2015 is a re-iteration of provision made in Sl 3, Addendum-1A to 2015, wherein it was provided that Higher CFAs can sanction cases coming within the powers of lower CFAs, within the same chain of CFAs in a particular sub-schedule.



REVIEW OF DFPDS 2015

1. Refer to MoD (Fin) letter CoordA-102 dated 26 Oct 15.
2. DFP 2006 vs DWP 07. The powers for “Works” to the *IN* were delegated by Gol in Feb 2007 and, thereafter, notified in the DWP in Jun 2007. It is requested to clarify whether ‘without IFA consultation’ powers, as mentioned in DWP 07, are restored as per the MoD order *ibid*.
3. Processing Cases with Nominated IFAs. Para 1.3 of the MoD order *ibid* states that “where IFAs are not posted, such cases may be sent for consideration by the next higher CFA in consultation with his IFA”. Both DFP 2006 and DFPDS 2015 provide powers to CFAs with IFA consultation irrespective of them having a co-located IFA. Cases are sent to the nearest nominated IFAs for processing. The requirement of sending the cases for sanction of the next higher CFA may also be clarified.

REVIEW OF DFPDS-2015

1. Ref MoD order No. Coord A-102 dt 26 Oct 2015.
2. In view of the directions issued vide Para 1.2 of MoD order under ref regarding withdrawal of inherent powers given vide DFPDS-2015, Addendum 1 to DFPDS and other special dispensation letters a clarification regarding status of sanctions issued up to 28 Oct 2015 needs to be given. It has to be clarified whether sanctions issued in exercise of the powers authorised as forgoing will be enforceable or not. The following clarification may, therefore, be issued:-

*"All sanctions/adm approval accorded upto 28 Oct 2015 under inherent powers authorised vide DFPDS 2015 and amendments thereof shall be valid. All cases under inherent powers wef 29 Oct 2015 shall be processed as per DFPR-2006".*
