Minutes of the 24th Annual Meeting of DASCB

The 24th Annual Meeting of Defence Accounts Sports Control Board was held on 18th of November 2024 at 03.00 pm in HQrs Office under the Chairmanship of Smt. Devika Raghuvanshi, IDAS, CGDA. The following officers were present.

- 2. At the outset, Secretary, DASCB welcomed the Chairperson of the DASCB alongwith other members. Thereafter, with the due permission of the Chairperson, the proceedings of the meetings were commenced.
- 3. First of all, action taken on the minutes of the 23rd DASCB meeting held on 10.08.2022 were discussed pointwise.
- 4. The Annual Sports Calendar for the Financial Year 2024-25 & 2025-26 was discussed and after due deliberation the chairperson agreed that the undermentioned tournaments may be held as per indicated schedule:-

Zonal rounds to be organized well before the All India Tournament as mentioned above to ensure the participation of the zonal team/teams as per directions of HQrs (DASCB), which will be issued in due course. Teams entries from all zones to be taken in r/o. these sports.

(Action: DASCB)

5. While deliberating on the sports and recreation facilities for staff in DAD residential complex, the Chairperson directed all the Zonal member PcsDA/CsDA/IFAs etc to take necessary action on the same.

(Action: All Zonal Members)

6. At the behest of the Chairperson, the matter of DASCB logo was discussed and the Chairperson directed that suggestions/entries for design of DASCB logo may be invited from the staff/officers of DAD and the best entry may be developed as the the DASCB logo.

(Action: DASCB)

7. The proposal for participation of a separate IDAS officers' team in DAD tournament was placed in disscussion which was accepted by the Chairperson in r/o. games planned & organized by DASCB.

(Action: DASCB)

8. During the meeting the matter of the relaxation for 02 hrs a day for the active sports quota persons was taken up and the Secretary informed that this relaxation already exists as conveyed vide DASCB Letter no DASB/10014/23rd meeting/2022 dated 20-10-2023. However, some issues came in to light in the form of suggestions and for clarity. In this regard, Shri Rozy Agarwal, IDAS, Sr. Joint CGDA (AN) suggested that PcsDA/CsDA concerned may take view on the relaxation and if deemed fit may regulate the relaxation in respect of active sports quota persons for 10 hrs in a week (twice a week or as per feasibility) instead of 2 hours a week depending upon peculiarities of sports & requirement. However, to improve/maintain their skills/games/sports and to avoid misusing this ralaxation period, the active sports players may be asked to produce the proof of participation.

(Action: All PCsDA/CsDA)

9. The matter of providing kit to the players who play for DASCB/National/State or any other affiliated tournament was discussed and the Chairperson directed that the kit can be purchased by the players as per the games/sports discipline upto the monetary limit of 5000/- and may be claimed/recouped from the DASCB, keeping in view the condition/time period of the earlier issued kit,if any.

10. A point from Shri Anand Agarwal, IDAS, Director (NADFM), Pune was placed in discussion regarding earmarking certain funds (atleast 5% of office contingency) for development of sports infrastructure and tournament expenses. This suggestion was accepted by the Chairperson and directed that this funds for the purpose may be earmarked from next financial year and earmarked fund may be used for this purpose systematically. This fund may also be reviewed in the month of Jan' 25 and if not spent for sports, may be redirected for other purposes.

11. IFA (CC) Lucknow raised a point to create and enhance sports infrastructure in training facilities (RTCs) across regions to develop a atmosphere and sense of sports culture for their staff and the trainees who participate from other offices. These facilities/infrasturcture can be utilised while organising DAD tournaments as well. Shri Rozy Agarwal, IDAS, Sr. Joint CGDA (AN) suggested to identify such spaces/facilites in RTCs and the proposal may be incorporated in the perspective plan. The Chairperson agreed upon this. In this regard it was also directed that zonal members may carry out survey in their respective zones & submit a list of available infrastructure in various offices for further action.

12. A suggestion came from Shri Anand Agarwal, IDAS, Director (NADFM) Pune to implement a structured sports quota recruitment process with clear vision, focusing on a few key sports disciplines. After due deliberation, the Chairperson agreed upon this recruitment process of the specialist sports persons and directed Shri Hari Har Mishra, IDAS, IFA(CC) Lucknow and Shri Anand Agarwal, IDAS, Director (NADFM) Pune to suggest the proposal through DASCB.

(Action: IFA (CC) Lucknow, Director (NADFM) Pune/DASCB/AN-VIII of Hqrs. Office)

13. The Secretary, DASCB suggested to establish a centralized database to monitor athlete/sports person participation, performance and progression for informed decision-making. Sr Jt CGDA(Admin) emphsised the importance of data creation relating to Sports Quota Players in order to utilise their services fully. The Chairperson was pleased with this point and further directed that data of the sports quota players may be collected from all Controllers so as to arrange the available sports persons as a team (sports wise) as when ever required , the available team may be utilised for participation in affiliated tournaments .Chairperson further desired that DASCB should make available the badges/monograms for the players of different disciplines to feel them proud of their unique identity in the office.

(Action: All Zonal Members/DASCB)

14. A proposal was extended by Shri Anand Agarwal, IDAS, Director (NADFM) Pune regarding the commendation and monetary incentives for notable achievements, based on a point system to foster competitive spirit. The Chairperson agreed with this proposal and directed that the players may be identified in various disciplines and awarded on the DAD Day 2025.

(Action: All Zonal Members/DASCB/AN-III & AN-V of Hqrs. Office)

15. A suggestion was placed on behalf of the CDA, Guwahati for regular updates on sports events, achievements, and notices via the DASCB webpage. Shri Sushil Riyar, IDAS, Joint Secretary, DASCB stated that these informations will be updated in DASCB column regularly on the CGDA website. The Chairperson agreed with the same.

(Action: All Zonal Members/DASCB/IT Wing of Hqrs. Office)

16. The points on behalf of the CDA, Guwahati & Director, NADFM Pune were placed regarding encouragement of participation of DASCB teams in national/regional tournaments and allow NOC for athletes to compete at the state level and create uniform directions for player participation in tournaments organized outside DASCB. The Secretary, DASCB informed that these procedures are being followed as per norms.

(Action: All PcsDA/CsDA/DASCB)

17. The IFA (CC) Lucknow & NADFM Pune proposed to introduce incentives for active sports persons, including exemptions from transfers for coaches over 35 years. The Secretary, DASCB informed that incentives are being given to the players as per rules and regulations as and when claimed by the players. Further, same relaxation to the players who on attaining the age of 35 years becomes the coach of a national/state team or affiliated body can be considered if claimed in terms of Hqrs office Letter No AN/X/10001/2/2015 dated 20-11-2017. Chairperson also directed Sr. Jt. CGDA (AN) to review the transfer policies in r/o. coaches/players & formulate clear cut guidelines for the same.

(Action: All PcsDA/CsDA/DASCB & AN-X of Hqrs. Office)

18. Shri Anand Agarwal, IDAS, Director (NADFM), Pune placed a suggestion to provide access to specialized coaching in identified sports disciplines. The IFA (CC) Lucknow also seconded this point quoting the guidelines of the Sports Ministy. The Chairperson agreed that the same may be considered on case to case basis wise through DASCB as per the DOP &T guidelines.

(Action: All PcsDA/CsDA/DASCB)

19. A suggestion put forth by Shri Anand Agarwal, IDAS, Director (NADFM), Pune for creating an engaging and informative annual publication, highlighting the achievements and participation of DAD staff and officers in various sports events throughout the year was accepted by the Chairperson. Therefore, it was directed to take initiative for publication of a Annual Edition of Sports Magazine on DAD Day with directions to collect the details relating to participation/achievements in various sports activities through a comprehensive quarterly report. The Quarterly report may be called by DASCB from the Controllers' offices in a standard/uniform form up to quarter ending June each year for incorporation of the four quarterly reports in the yearly sports magazine.

(Action: All Zonal Members/DASCB/AN-III & AN-V of Hqrs Office)

20. Shri Anand Agarwal, IDAS, Director (NADFM), Pune & IFA (CC) Lucknow suggested to nominate two sports representatives to participate in DASCB meetings to voice player concerns i.e. 01 from Men's category and 01 from Women's category. On this suggestion the Chairperson directed that 01 player from each game may be allowed to join the meeting through VC as per feasibility.

(Action: DASCB)

Proceedings of the meeting ended with a vote of thanks to the chair.
