

The Competent Authority, DASCB, HQrs Office has approved to hold 10<sup>th</sup> All India DAD Table Tennis Tournament, 2025-26 (Men & Women). The Office of PCDA(O) Pune and NADFM Pune have been entrusted with the responsibility to jointly organize the subject tournament at Pune station as per the approved calendar issued vide Minutes of 24<sup>th</sup> Annual Meeting of DASCB uploaded on CGDA website. The tournament is planned to be held from 06.04.2026 to 08.04.2026 (tentative dates).

2. The said tournament will be organized under three different categories "sports quota", "non sports quota" & "IDAS" separately for **Men, Women and Mixed subcategory**. The participant teams under non-sports quota category shall comprise **3 men and 2 women players**. All the matches will be played in accordance with laws of Table Tennis approved by Table Tennis Association of India. As per the directions of DASCB HQrs office, players should be provided with player's kit by the concerned PCDA/CDA offices.
3. NADFM/PCDA(O), Pune will arrange lodging/boarding facilities in designated hotels on payment basis, if opted by the players. Participant's willingness or otherwise in this regard may kindly intimated through email ([cdao-pun.cgda@nic.in](mailto:cdao-pun.cgda@nic.in)) under the specific mention of subject as "**Accommodation for T.T. Tournament**". The Participants may be directed to plan travel to ensure they reach Pune station on 5<sup>th</sup> April 2026 and leave Pune station only after the closing ceremony in the evening hours of 8<sup>th</sup> April 2026. The accommodation & travel arrangement shall be accordingly arranged by this office.
4. As per the DASCB letter under reference, all willing Table Tennis Sports Quota players and IDAS Officers will have direct entry in the tournament and their names may be sent directly to this office. **All offices under Proforma control of CDA/PCDA offices shall send their players' entry through their Proforma Controllers only.**




